





The intervention of the San Francesco di Paola Tourist Port, under project financing that may require the implementation of the Integrated Intervention Program (PINT), is divided into:

- "Marina Project," the cost of which has been estimated at a total cost of € 54.391.031,94, of which € 20.067.771,71 is from FSC 2021 2027 resources.
- "Railway Areas Regeneration Project", which provides for the purchase and sale of the FSSU Areas by public deed will take place no later than 30 (thirty) days after the award in favor of the economic operator that will be selected at the closing of the project financing procedure.
